**ORDINANCE NO.: 496
BOROUGH OF ALDAN LOCAL SERVICES TAX**

An Ordinance of the Borough of Aldan providing revenue for police, fire (or emergency) services, road construction, property tax relief, and highway maintenance purposes by imposing a tax on the privilege of engaging in occupations on each engagement in any occupation whatsoever within the limits of the Borough of Aldan, at the maximum rate allowed by statute, currently set at Fifty-Two (\$52.00) dollars per year on each such engagement; providing for its levy, enforcement and collection from each individual exercising such occupation; imposing upon employers the duty of collecting said tax and remitting and paying over the same to the Borough Tax Officer; and imposing penalties. Ordained and enacted by the Council of the Borough of Aldan pursuant to the authority of the Pennsylvania Local Tax Enabling Act, P.L. 1257 Act 511 of 1965, effective January 1, 1966 (codified at 53 P.S. §6901 et. seq.) and its amendments, specifically Act 7 of 2007, adopted on June 21, 2007, as follows:

SECTION 1: Short Title.

This Ordinance shall be known and may be cited as "The Borough of Aldan Local Services Tax Ordinance."

SECTION 2: Definitions.

The following words and phrases, when used in this Ordinance, shall have the meanings ascribed to them in this section, except where the context or language clearly indicates or requires a different meaning:

BOROUGH OF ALDAN or **BOROUGH** – The area within the corporate limits of the Borough of Aldan.
